General Conditions:

Entry:

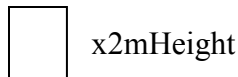
1. Enrolment/ Entry form, including all information and attachments are needed, as well as the entry fee (please see entry form).
This must be received No **later then 15th November**.
Early submissions insure your participation.
2. The Gallery/Centre, reserves the sole right to cancel any entry or to cancel the whole exhibition at any time and for any reason, (without basis for any claims).

In case cancellation was initiated by the gallery without breach of terms by the artist, the gallery will return the entry fee in full.

Display space and duration of Exhibition:

3. Indoor display artists, are limited to 2 pieces of artwork per artist

Maximum display area for each artist*:



x2mHeight

x1mWidth

*These conditions can be negotiable. Please contact the gallery if there are problems meeting these requirements, we can be flexible within reason.

To get the best possible results, approval by the Gallery beforehand is necessary.

4. Outdoor exhibitors have few limitations with the number of works exhibited but are limited to 2 works chosen by the artist, to be printed in the catalogue.

5. Duration of each exhibition will be determined by the centre from time to time; early notice will be given every year before enrolment.
The centre is obligated to a minimum duration of a whole weekend after opening night.

Art Exhibited:

6. All artwork must be original.
Prints, computer generated or art exhibited at the Nut Point Gallery in previous years will NOT be accepted.
7. If you are a well known, established artist, please bear in mind that it is possible that your work viewed on the opening night may have been seen previously.
Your reputation is important to us.
8. The Gallery reserves the right to decline any unsuitable artwork for any reason and the gallery's decision is not negotiable.

Opening Night Invitations:

9. To enable the smooth entry for your guests arriving on the opening night, please provide their details on your entry form. If this is not possible, please let us have their details as soon as possible.

Liability:

10. The Gallery/Centre has a security system covering all the relevant property area, A guard dog is also present. The premises are usually occupied and there is a monitoring system in place. However, no liability for any loss or damage will be accepted and work will remain the sole responsibility of the artist.

Costs:

11. An entry fee of **\$65.00** from each artist will contribute towards the opening night festivities, including wine, waiters, music and security.

Your money also goes towards advertising, printing and postage for the exhibition over the following week.

12. We request that the contribution payment accompany the enrolment form, to reach "The Nut Point" or BNZ 02-0800-0890144-000 account number by **15th November at the latest.**

Fee will be non-refundable unless artist is declined by the gallery.

13. To keep costs down, and quality up, we ask that each artist supply **two plates of finger food** (or more if you'd like to show your culinary skills), that will complement this special event.

An option for a fee that includes your finger food is available on the entry form.

Commission for artwork sold:

14. Art work sold on this event, will incur a 28 % commission.

15. Your asking price indicated on your form should include GST and commission. It is best to set your price which will include GST (which will be deducted from accountability with **unregistered GST artist**)
